

DIRECTIONS TO HAMILTON, BURGESS, YOUNG & POLLARD, *pllc*, FROM CHARLESTON

- Travel **I-77 SOUTH** for approximately **40 miles**
- Take **MOSSY (WV-612) – Exit 60**
- At end of exit ramp, turn **LEFT**
- Go across small bridge
- At stop sign, turn **RIGHT** (Exxon gas station will be on left)
- Follow that road – it is a 2 lane road – for approximately **8 miles**
- At 4-way intersection (country store on right), proceed **STRAIGHT** through intersection after stopping at stop sign.
- Two sharp curves ahead – keep following road – you will come to 4-lane highway – **ROUTE 19**
- Cross highway and turn **LEFT** onto **ROUTE 19 NORTH**
- Proceed approximately **9 miles** on **Route 19 North** to **OAK HILL**
 - proceed through 2 sets of traffic lights on Route 19
 - Fayette Square Shopping Center (Shoney’s, Kroger, K-Mart, etc.) on left
- Continue on **Route 19 North** to another set of traffic lights at Fayette Town Shopping Center
 - Super WalMart on right – about 1 mile past Fayette Square Shopping Center
- Take the next exit to the **LEFT - Maple Lane**
- Hamilton, Burgess, Young & Pollard is **2ND BUILDING** on **LEFT** – red brick with pillars
- Parking is beside the building

- Take **I-77 North** to Beckley, West Virginia
- Take **Exit 48** (North Beckley Exit) – you will be on **US Route 19 North**
- Follow **Route 19 North** approximately **15 miles** to **OAK HILL**
 - Proceed through 2 sets of traffic lights on Route 19
 - Fayette Square Shopping Center (Shoney's, Kroger, K-Mart, etc.) on left
- Continue on **Route 19 North** to another set of traffic lights at Fayette Town Shopping Center
 - Super WalMart on right – about 1 mile past Fayette Square Shopping Center
- Take the next exit to the **LEFT - Maple Lane**

- Travel I-79 South
- Take the **Beckley/Summersville Exit (Route 19 SOUTH)**
- Travel on **ROUTE 19 SOUTH** for approximately **45 miles** to **Summersville**
- Continue on **ROUTE 19** for approximately **25 miles** to **Fayetteville**
- Proceed approximately **1 mile** on **Route 19 SOUTH** through **FAYETTEVILLE**
 - proceed through 2 sets of traffic lights on **Route 19 SOUTH**
 - Tudor's, Comfort Inn, Dairy Queen, CoMac (on left)
- After the second set of traffic lights, take the next exit to the **RIGHT - Maple Lane**
- Hamilton, Burgess, Young & Pollard is **2ND BUILDING** on **LEFT** – red brick with pillars

- Take **North Beckley Exit 48**. You will be on **US Route 19 North**

 - Fayette Square Shopping Center (Shoney's, Kroger, K-Mart, etc.) on left
- Continue on **Route 19 North** to another set of traffic lights at Fayette Town Shopping Center
 - Super WalMart on right – about 1 mile past Fayette Square Shopping Center

 - proceed through 2 sets of traffic lights on **Route 19 SOUTH**
 - Tudor's, Comfort Inn, Dairy Queen, CoMac (on left)
- After the second set of traffic lights, take the next exit to the **RIGHT - Maple Lane**
